## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 10ct yellow gold and rhodium plated, diamond set, multistone ring, of cast construction.

Plain, narrow, low half round, tapered band of 1.64mm width (at base) x 1.34mm depth, with a hollow top and shoulders, and open back settings.

Feature one row of alternating, one larger round brilliant cut diamond, with two smaller round brilliant cut diamonds, spanning across the top of the band. There are a total of eleven round brilliant cut diamonds. The diamonds graduate in size, largest to the centre, and end set. The settings are secured between the shoulders of the plain and polished band. Rhodium plating to the inside of the settings.

Polished finish.

Stamped '10K MHJ' - acid tested as 9 carat gold.

Ring size: K 1/2.

The ring contains:

Three end set round brilliant cut diamonds, clarity is "Vs & SI & P1" (mixed), colour is "H".

Dimensions = 2.39mm(Dia) x 1.46mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.55mm(Dia) x 1.56mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.10ct (estimated - see NOTE below)

Eight end set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "H".

Dimensions (average) = 1.32mm(Dia) x 0.81mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.09ct (estimated - see NOTE below)

Total Item Weight = 1.98 grams Total Gemstone Weight = 0.19ct Total Metal Weight = 1.94 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
