Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold, diamond set, multistone ring, of cast construction.

Plain, narrow, low half round, tapered band of 3.13mm width (at base) x 0.79mm depth, with open back settings, and a curved underrail.

Feature two rows of nine round brilliant cut diamonds, spanning across the top of the band, varying in size and channel set. The settings are secured between the tapering shoulders of the plain and polished band.



Polished finish.

Stamped '18K' - acid tested as 18 carat gold.

Ring size: W.

The ring contains:

Eighteen channel set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "H to I" (mixed).

Dimensions (average) = 2.00 mm(Dia) x 1.22mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.50ct (estimated - see NOTE below)

Total Item Weight = 6.88 grams Total Gemstone Weight = 0.50ct Total Metal Weight = 6.78 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
