Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct white gold, diamond set, multistone, 'cluster' style ring, of cast construction.

Plain, narrow, low half round, tapered band of 2.27mm width (at base) x 1.15mm depth, with hollow top and shoulders, and open back settings.

Feature central 'flower' style cluster, housing seven round brilliant cut diamonds, largest to the centre, claw set. The top plate is secured between the tapering shoulders of the plain and polished band. Each of the shoulders has one diagonal row of three graduating round brilliant cut diamonds, claw set.



Polished finish. Stamped '375' - acid tested as 9 carat gold. Ring size: L.

The ring contains:

One claw set round brilliant cut diamond, clarity is "P2", colour is "H"

Dimensions = 2.23mm(Dia) x 1.36mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.04ct (estimated - see NOTE below)

Eight bead set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "H to I" (mixed).

Dimensions = 1.42mm(Dia) x 0.87mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.00mm(Dia) x 1.22mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.21ct (estimated - see NOTE below)

Total Item Weight = 3.04 grams Total Gemstone Weight = 0.25ct Total Metal Weight = 2.99 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
