Valuation for Traditional Retail Insurance Replacement

Item 1

One, 10ct white gold, diamond set, multistone ring, of cast construction.

Plain, narrow, low half round, tapered band of 1.71mm width (at base) x 1.08mm depth, with a curved underrail.

Feature central four claw setting, housing one round brilliant cut diamond, claw set. The setting is secured to the underrail and in between the extended and pointed shoulders, of the plain and polished band. The decorative gallery is embellished with twenty single cut diamonds, bead set.

Polished finish.

Stamped '10K michael hill 1.00 TDW' - acid tested as 9 carat gold.

Ring size: O.

The ring contains:

One claw set round brilliant cut diamond, clarity is "P1", colour is "K".

Dimensions = 6.16mm(L) x 6.15mm(W) x 3.85mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.90ct (estimated - see NOTE below)

Twenty bead set single cut diamonds, clarity is "Si & P1" (mixed), colour is "J to K" (mixed).

Dimensions = 0.94mm (diameter) (smallest)

Dimensions = 1.02mm (diameter) (largest)

Total Weight = 0.10ct (estimated - see NOTE below)

Total Item Weight = 2.47 grams Total Gemstone Weight = 1.00ct Total Metal Weight = 2.27 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
