Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's, hand finished, raised 18ct yellow gold & diamond set, solitaire ring. Plain, narrow, low half round, tapered band, measures 2.43mm width (at base) x 1.38mm depth, with curved underrail.

Feature, "solitaire style" ring design, Comprising, a raised cross-over six claw setting to top, houses one round brilliant cut diamond, (laser inscribed) claw set. The extended shoulders, of the band, tapers up to the top, split, cross over & spear-pointed end terminations, to both sides.

Polished finish, stamped "750, JFJ" - acid tested as 18 carat gold.



Finger size = M1/2.

One claw set round brilliant cut diamond, clarity is "Si2", colour is "G", excellent cut quality.

Dimensions = 5.24mm-5.26mm (average diameter) x 3.13mm (D-estimated) x 3.50%(Girdle Thickness)

Total Weight = 0.52ct (estimated - see NOTE below).

Total Item Weight = 3.40 grams, Total Gemstone Weight = 0.52ct, Total Metal Weight = 3.30 grams (estimated)

NOTE: Limited gemmological testing inset. No certification sighted or presented at the time of this valuation. However the diamond has been certified by, and is the opinion of, Messrs. Gemological Institute of America, Certificate no. 6271071556 Dated September 27th 2017. The diamond has also been laser inscribed upon the girdle with GIA (logo) and 6271071556. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
