## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, lady's hand finished, 14ct white gold & yellow gold, multistone ring. Plain, narrow, low half round, tapered band, measures, 1.55mm width (at base) x 1.24mm depth, with curved underrail. Feature, drop down cluster with split shoulders & undercarriage stones, claw set. The extended shoulders, of the band tapers up splits at the termination, to both sides.

Polished finish, stamped "14K michael hill 45033900209" - acid tested as 14 carat gold. Finger size = L.

The ring contains:

One claw set round brilliant cut diamond, clarity is "Si2", colour is "I", medium cut quality.

Dimensions = 4.17-4.19mm (diameter) x 2.86mm (D-estimated)

Total Weight = 0.33ct (estimated - see NOTE below).

One Hundred And Forty Two claw set round brilliant cut diamonds, clarity is "Si P1 & P2"(mixed), colour is "I to J"(mixed), medium cut quality.

Dimensions = 0.80mm (average diameter) x 0.49mm (D-estimated) (smallest)

Dimensions = 1.60mm (average diameter) x 0.98mm (D-estimated) (largest)

Total Weight = 0.62ct (estimated - see NOTE below).

Two rub-over set round sapphires, colour is "medium dark pink".

Dimensions = 1.40mm (average diameter) x 0.85mm (D-estimated)

Total Weight = 0.02ct (estimated - see NOTE below).

Total Item Weight = 3.86 grams, Total Gemstone Weight = 0.97ct, Total Metal Weight = 3.66 grams (estimated)

NOTE: Limited gemmological testing, inset. However the centre stone is laser inscribed, (michael hill 45033900209, no certification or paperwork was presented or sighted at the time of this valuation. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
