Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and rhodium plated, multistone, gem set ring, of cast construction.

Plain, wide, tapered band of 15.05mm at top to 6.48mm in width (at base) x 1.25mm depth, hollow top and shoulders, and open back settings.

Feature ten row ring design, housing a total of one hundred and eighty Princess cut diamonds, tapering in size, invisible set. Rhodium plating to the setting area.

Polished finish.

Stamped '750 UD 2.00' - acid tested as 18 carat gold.

Finger size is N.

The ring contains:

One Hundred And Eighty invisible set Princess cut diamonds, clarity 'Si & P1' (mixed), colour 'G to I' (mixed).

Dimensions = 1.25mm to 1.35mm(diameters) x 0.65mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 2.00ct (estimated - see NOTE below)

Total Item Weight = 11.90 grams

Total Gemstone Weight = 2.00ct

Total Metal Weight = 11.50 grams (estimated)



NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
