Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's raised 14ct white gold & gemset, multistone ring, of cast construction.

Plain, narrow, low half round, tapered band, measures 1.59mm width (at base) x 1.16mm depth, with curved underrail, open back settings underneath.

Feature, raised four claw setting to top, houses one Princess cut diamond, claw set. The extended shoulders, of the band tapers up wide to the top, contains a single row across the top, below the central setting, ten Princess cut diamonds, channel set.



Polished finish, stamped "585" - acid tested as 14 carat gold. Finger size = K1/2.

The ring contains;

One claw set Princess cut diamond, clarity is "P2", colour is "I", medium cut quality.

Dimensions = 4.15mm (L) x 4.15mm (W) x 3.20mm (D-estimated)

Total Weight = 0.45ct (estimated - see NOTE below).

Ten channel set Princess cut diamonds, clarity is "P1 & P2"(mixed), colour is "H to I"(mixed), medium cut quality.

Average dimensions = 2.00mm (L) x 2.00mm (W) x 1.42mm (D-estimated)

Total Weight = 0.45ct (estimated - see NOTE below).

Total Item Weight = 3.71 grams, Total Gemstone Weight = 0.90ct, Total Metal Weight = 3.53 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
