Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and 18ct white gold, gem set, multistone ring, of hand-assembled construction.

Plain, narrow, low half round band of 2.25mm width (at base) x 1.32mm depth, with a curved underrail.

Feature central white gold four claw setting, housing one Princess cut diamond, claw set. The setting is secured between the extended and pointed shoulders, in a 'wrap around' style, of the plain and polished yellow gold band. Each of the shoulders houses one row of three round brilliant cut diamonds, graduating in size, and channel set.

Polished finish.

Stamped '18ct' - acid tested as 18 carat gold.

Ring size: N.

The ring contains:

One claw set Princess cut diamond, clarity is "Si1", colour is "G".

Dimensions = 4.19mm(L) x 4.17mm(W) x 2.95mm(D-estimated) x 8%(Girdle Thickness)

Total Weight = 0.44ct (estimated - see NOTE below)

Six channel set round brilliant cut diamonds, clarity is "Si", colour is "G to H" (mixed).

Dimensions = 1.23mm(Dia) x 0.75mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.41mm(Dia) x 0.86mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.06ct (estimated - see NOTE below)

Total Item Weight = 3.68 grams Total Gemstone Weight = 0.50ct Total Metal Weight = 3.57 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
