Valuation for Traditional Retail Insurance Replacement

Item 1

One, pair of hand-assembled raised, 18ct white gold & gemset, screw-back stud earrings.

Feature, each having a square-shaped step down cluster setting, houses one round brilliant cut diamond, to centre illusion set. Drops to a double surround containing thirty two round brilliant cut & single cut diamonds, bead set. Both earrings come with, threaded posts and butterfly fitted attached.

Polished finish, stamped "750 R" - acid tested as 18 carat gold.

Earring dimensions = 8.17mm (L) x 8.11mm (W) x 4.39mm (D).

The earrings contain:

Two illusion set round brilliant cut diamonds, clarity is "Si", colour is "G to H"(mixed), medium cut quality.

Dimensions = 2.50mm (average diameter) x 1.53mm (D-estimated)

Total Weight = 0.12ct (estimated - see NOTE below).

Sixty Four bead set round brilliant cut diamonds, clarity is "Si", colour is "H to I"(mixed), medium cut quality.

Dimensions = 0.90mm (average diameter) x 0.55mm (D-estimated) (smallest)

Dimensions = 1.20mm (average diameter) x 0.73mm (D-estimated) (largest)

Total Weight = 0.32ct (estimated - see NOTE below).

Total Item Weight = 3.19 grams, Total Gemstone Weight = 0.44ct, Total Metal Weight = 3.10 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar pair of screw back stud earrings, employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
