Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, multistone ring, of hand-assembled construction.

Plain, narrow, low half round band of 1.70mm width (at base) x 0.67mm with open back settings, and a curved underrail.

Feature central six claw setting, housing one round brilliant cut diamond, claw set. The setting is secured to the underrail, and in between the extended and pointed shoulders, in a 'wrap around' style, of the plain and polished band.

Polished finish.

Stamped '750' - acid tested as 18 carat gold.

Ring size: K 1/2.

The ring contains:

One claw set round brilliant cut diamond, clarity is "Si1", colour is "H".

Dimensions = 4.78mm(L) x 4.75mm(W) x 3.15mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.45ct (estimated - see NOTE below)

Ten channel set round brilliant cut diamonds, clarity is "Si", colour is "G to I" (mixed).

Dimensions = 1.20mm(Dia) x 0.73mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.47mm(Dia) x 0.90mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.12ct (estimated - see NOTE below)

Total Item Weight = 2.37 grams Total Gemstone Weight = 0.57ct Total Metal Weight = 2.26 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
