Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and platinum, gem set, 'solitaire' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 1.72mm width (at base) x 0.89mm depth.

Feature central platinum illusion plate, within a four claw setting, housing one round brilliant cut diamond, claw set. The setting is secured to the top of the plain and polished yellow gold band. The shoulders are embellished with 'scroll' detail.

Polished finish.

Stamped '18CT PLAT' - acid tested as 18 carat gold and platinum.

Ring size: T.

The ring contains:

One claw set round brilliant cut diamond, clarity is "Si1", colour is "G".

Dimensions = 3.78mm(L) x 3.77mm(W) x 2.25mm(D-estimated) x 3.25%(Girdle Thickness)

Total Weight = 0.20ct (estimated - see NOTE below)

Total Item Weight = 3.22 grams

Total Gemstone Weight = 0.20ct

Total Metal Weight = 3.18 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
