## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, 18ct yellow gold and 18ct white gold, gem set, 'cluster' style ring, of handmade construction.

Plain, narrow, flat band of 2.88mm width (at base) x 0.99mm depth with open back settings, and a curved underrail.

Feature navette shaped white gold 'cluster' of three claw settings, each housing a total of twenty-three round brilliant cut diamonds, claw set. The settings are supported with an open wire base, and is secured to the underrail, and in between the 'split' style shoulders, of the plain and polished yellow gold band.



Polished finish.

Stamped '750' - acid tested as 18 carat gold.

Ring size: O 1/2.

The ring contains:

Twenty Three claw set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "G to H" (mixed).

Dimensions = 2.24mm(Dia) x 1.37mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.31mm(Dia) x 1.41mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 1.00ct (estimated - see NOTE below)

Total Item Weight = 5.85 grams Total Gemstone Weight = 1.00ct Total Metal Weight = 5.65 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
