Valuation for Traditional Retail Insurance Replacement

Item 1

One pair of, 9ct yellow gold, gem set, stud earrings, of hand-assembled construction.

Feature railed four claw settings, each housing one round brilliant cut diamond, claw set. The earrings are finished with post and butterfly attachments.

Earring dimensions = 3.45mm (ave. length) x 3.45mm (ave. width) x 3.32mm (ave. depth).

Polished finish.

Stamped '375' - acid tested as 9 carat gold.

The earrings contains:

Two claw set round brilliant cut diamonds, clarity is "P2", colour is "I to J" (mixed).

Dimensions = 3.34mm(Dia) x 2.04mm(D-estimated) x 3%(Girdle Thickness) (smallest)

Dimensions = 3.45mm(Dia) x 2.10mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.29ct (estimated - see NOTE below)

Total Item Weight = 0.54 grams

Total Gemstone Weight = 0.29ct

Total Metal Weight = 0.48 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pair of earrings employing similar materials and techniques being for a retail insurance purpose only.
