Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and 18ct white gold, 'solitaire' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 2.14mm width (at base) x 1.37mm depth.

Feature central white gold six claw setting, housing one round brilliant cut diamond, claw set. The setting is secured to the top of the extended and pointed shoulders, of the plain and polished yellow gold band.

Polished finish.

Stamped '18K michael hill 536295726' - acid tested as 18 carat gold.

Ring size: Q.

The ring contains:

One claw set round brilliant cut diamond, clarity is "P1", colour is "F".

Dimensions = 6.22mm(L) x 6.18mm(W) x 4.02mm(D-estimated) x 5%(Girdle Thickness)

Total Weight = 1.00ct (known weight - see NOTE below)

Total Item Weight = 3.74 grams

Total Gemstone Weight = 1.00ct

Total Metal Weight = 3.54 grams (estimated)



NOTE: The diamond has been certified by and is the opinion of Messrs. International Gemological Institute, Certificate no. 536295726 Dated July 13, 2022. The diamond has also been laser inscribed upon the girdle with IGI (logo) and 536295726 and michael hill. Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
