Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold, gem set, 'three stone' style ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 2.72mm width (at base) x 1.28mm depth, with open back settings.

Feature central bezel setting, housing one emerald cut natural emerald, bezel set. Either side of the central setting is one bezel setting, each housing one Princess cut diamond, bezel set. The settings are secured between the tapering shoulders, of the plain and polished band.

Polished finish.

Stamped '18ct' - acid tested as 18 carat gold.

Ring size: N.

The ring contains:

One bezel set emerald cut natural emerald, colour is "green".

Dimensions = 4.86mm(L) x 4.28mm(W) x 3.51mm(D-estimated)

Total Weight = 0.50ct (estimated - see NOTE below)

Two bezel set Princess cut diamonds, clarity is "Si", colour is "H".

Dimensions (average) = 3.18mm(L) x 3.00mm(W) x 2.13mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.30ct (estimated - see NOTE below)



Total Item Weight = 4.50 grams Total Gemstone Weight = 0.80ct Total Metal Weight = 4.34 grams (estimated)

NOTE: There is a significant fracture to the crown facets, of the central emerald. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
