Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand assembled 14ct yellow / white gold, multi-stone, ring set, of cast construction. The set comprising a 14ct yellow gold and 14ct white gold diamond set engagement ring with a fitted and matching 14ct yellow gold diamond set wedding ring. Each ring having a plain, narrow, low half round, tapered band with a combined basal width of 3.30mm x 1.25mm in depth.

The engagement ring has a central white gold six claw setting, housing one marquise cut diamond, claw set. The setting is secured to the underrail, and in between the extended and pointed shoulders, in a 'wrap around' style. Each of the shoulders houses two rows of nine baguette cut diamonds, graduating in size, largest to the centre, and channel set. Rhodium plating to the baguette cut diamond setting areas.



The fitted and matching wedding ring, has two clusters of five round brilliant cut diamonds, claw set. The separate wedding band fits around the central setting of the engagement ring.

Polished finish. Stamped '14K MHJ' - acid tested as 14 carat gold. Ring size: O. The ring set contains:

One claw set marquise cut diamond, clarity is "P1", colour is "H".

Dimensions = 5.78mm(L) x 3.37mm(W) x 2.30mm(D-estimated) x 6%(Girdle Thickness)

Total Weight = 0.27ct (estimated - see NOTE below)

Thirty Six channel set baguette cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "H to I" (mixed).

Dimensions = 1.01mm(L) x 0.69mm(W) x 0.50mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.76mm(L) x 1.28mm(W) x 0.93mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.48ct (estimated - see NOTE below)

Ten claw set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "H to I" (mixed).

Dimensions = 1.41mm(Dia) x 0.86mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.99mm(Dia) x 1.21mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.25ct (estimated - see NOTE below)

Total Item Weight = 7.50 grams Total Gemstone Weight = 1.00ct Total Metal Weight = 7.31 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring set employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
