## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, 9ct yellow gold and rhodium plated, gem set, flexible link bracelet, of hand-assembled constrcution.

Feature long rectangle domed style link, alternating with a 'cross' style link. Each of the eight long links house four rows of eleven round brilliant cut diamonds, pave set. There are a total of three hundred and fifty-one round brilliant cut diamonds, and one single cut diamond. The bracelet is finished with a box clasp, and a figure 8 safety catch. Rhodium plating to the diamond setting areas.



Braclet dimensions = 17.50cm (ave. length) x 8.51mm (ave.width) 4.80 (ave. depth).

Polished finish.

Stamped '10K' - acid tested as approximately 10 carat gold.

The bracelet contains:

Three Hundred And Fifty Two pave set round brilliant cut and single cut diamonds, clarity is "P2 & P3" (mixed), colour is "H to tinted brown" (mixed).

Dimensions = 1.43mm(Dia) x 0.87mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.75mm(Dia) x 1.07mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 5.50ct (estimated - see NOTE below)

Total Item Weight = 18.61 grams Total Gemstone Weight = 5.50ct Total Metal Weight = 17.48 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
