Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct yellow gold and rhodium plated, gem set, multistone ring, of cast construction.

Plain, narrow, low half round, tapered band of 3.54mm width (at base) x 1.11mm depth, with a hollow top and shoulders, and open back settings.

Feature domed style ring, housing a total of fifty-nine round brilliant cut diamonds, spanning across the top of the band. The diamonds vary slightly in size, and are pave set. The settings are secured between the tapering shoulders, of the plain and polished band. Rhodium plating to the diamond setting areas.

Polished finish.

Stamped '375' - acid tested as 9 carat gold.

Ring size: V.

The ring contains:

Fifty Nine pave set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "light tinted brown".

Dimensions = 1.63mm(Dia) x 0.99mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.78mm(Dia) x 1.09mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 1.00ct (estimated - see NOTE below)

Total Item Weight = 6.94 grams

Total Gemstone Weight = 1.00ct

Total Metal Weight = 6.74 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
