## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 9ct white gold, gem set, multistone, 'cluster' style ring, of cast construction.

Plain, narrow, low half round band of 2.05mm width (at base) x 0.77mm depth, and hollow top and shoulders, open back settings, and a curved under rail.

Feature central four claw setting, housing one oval glass (paste) type material, claw set. Surrounding is one row of twenty round cubic zirconias, claw set. The top plate is secured between the extended, pointed and cut out shoulders. Each of the shoulders houses six round cubic zirconias, claw set. The top plate is supported with an open gallery.

Polished finish.

Stamped '375 (partial)' - acid tested as 9 carat gold.

Ring size: P1/2.

The ring contains:

One claw set oval shaped glass (paste) type material, colour is "medium green".

Dimensions = 6.12mm(L) x 4.09mm(W) x 2.54mm(D-estimated)

Total Weight = 0.36ct (estimated - see NOTE below)

Thirty Two claw set round cubic zirconias.

Dimensions = 0.90mm(Dia) x 0.55mm(D-estimated) (smallest)

Dimensions = 1.00mm(Dia) x 0.61mm(D-estimated) (largest)

Total Weight = 0.32ct (estimated - see NOTE below)

Total Item Weight = 1.70 grams Total Gemstone Weight = 0.68ct Total Metal Weight = 1.56 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
