Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's Hand finished, raised 9ct white gold & diamond set, multistone ring. Plain, narrow, low half round, tapered band, measures, 1.59mm width (at base) x 0.91mm depth, with open back, underneath, hollowed out shoulders.

Feature, "trilogy style" ring design. Comprising, a raised square-shaped rub-over setting, contains four Princess cut diamonds, grouped together, illusion/rub-over set. Flaned to each side one Princess cut diamond, rub-over set. The extended shoulders, of the band, taper up to the top, from both sides.



Polished finish, stamped "375, GM16" - acid tested as 9 carat gold.

Finger size = J1/2.

The ring contains;

Six rub-over & illusion set (mixed), Princess cut diamonds, clarity is "Si & P1"(mixed), colour is "H to I"(mixed), medium cut quality.

Average dimensions = 1.89mm (L) x 1.89mm (W) x 1.34mm (D-estimated) (smallest) Average dimensions = 2.25mm (L) x 2.25mm (W) x 1.60mm (D-estimated) (largest)

Total Weight = 0.30ct (estimated - see NOTE below).

Total Item Weight = 2.20 grams, Total Gemstone Weight = 0.30ct, Total Metal Weight = 2.14 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
