## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, 9ct yellow gold and rhodium plated, gem set, dress style ring, of cast construction.

Plain, narrow, tapered band of 2.02mm in width (at base) x 0.89mm depth, with hollow top and shoulders, and open back settings.

Feature central four claw setting, housing one oval cut and faceted natural sapphire, claw set. To either side is four round brilliant cut diamonds, bead set with rhodium plating to the setting area. All secured between the extended and pierced shoulders of the plain and polished band.



Polished finish - stamped '9K GTV 375' - acid tested as 9 carat gold. Assayed in Birmingham, England. Finger size is N.

The ring contains:

One claw set mixed cut oval shape natural sapphire, colour 'dark yellow'.

Dimensions = 7.19mm(L) x 5.24mm(W) x 3.53mm(D-estimated)

Total Weight = 1.12ct (estimated - see NOTE below)

Eight bead set round brilliant cut diamonds, clarity 'P2 & P3' (mixed), colour 'G to H' (mixed).

Dimensions (average) = 1.70mm(Dia) x 1.04mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.16ct (estimated - see NOTE below)

Total Item Weight = 2.72 grams - Total Gemstone Weight = 1.28ct - Total Metal Weight = 2.46 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
