## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 10ct white gold, multistone, gem set ring, of cast construction. Plain, narrow, tapered band of 1.94mm in width (at base) x 1.25mm depth.

Feature central 'cluster' setting, housing nine round brilliant cut diamonds, tapering in size from centre and alternating surrounds, claw set. The single outer row having twenty round brilliant cut diamonds, with one round brilliant cut diamond, to each side under the setting. All secured between the shoulders of the plain and polished band. Each shoulder having twenty-three round brilliant cut diamonds, tapering in size, in a three row design, finishing with 'cross-over' terminations. Millegrain edging to all setting areas.

Polished finish.

Stamped '10K 0.50 michael hill' - acid tested as approximately 10 carat gold. Finger size is O.

The ring contains:

Fifty Five claw set round brilliant cut diamonds, clarity 'P2 & P3' (mixed), colour 'I to J' (mixed).

Dimensions = 1.00mm(Dia) x 0.61mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.00mm(Dia) x 1.22mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.50ct (estimated - see NOTE below)

Total Item Weight = 3.57 grams

Total Gemstone Weight = 0.50ct

Total Metal Weight = 3.47 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
