## Valuation for Traditional Retail Insurance Replacement

One, 9ct white gold, multistone, gem set ring, of cast construction.

Plain, narrow band of 1.64mm in width (at base) x 0.98mm depth.

Feature stepped down ring design, housing five Princess cut diamonds, tapering in size, semi channel set. All secured between the shoulders of the plain and polished band.

Polished finish.

Stamped '375' - acid tested as 9 carat gold.

Finger size is M.

The ring contains:

Five stepped channel set Princess cut diamonds, clarity 'Vs & Si' (mixed), colour 'H to I' (mixed).

Dimensions = 2.06mm(L) x 2.05mm(W) x 1.40mm(D-estimated) x 2%(Girdle Thickness) (smallest) Dimensions = 2.63mm(L) x 2.60mm(W) x 1.85mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.30ct (estimated - see NOTE below)

Total Item Weight = 1.70 grams Total Gemstone Weight = 0.30ct

Total Metal Weight = 1.64 grams (estimated)
