Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand finished raised, 14ct white gold & diamond set, cluster dress ring. Plain, narrow, low half round, tapered band, measures 2.00mm width (at base) x 1.04mm depth, with curved underrail.

Feature, "square shaped cluster" style ring, with shoulder & undercarriage stones. Comprising a raised four claw setting to centre, drops to a surround, mill graing edged & bead set, filigree walls. The extended shoulders, of the band, taper up with bead set centre, filigree side walls. The under carriage both sides, having a filigree pattern, with a lozenge-shaped, bead setting to their centre.



Polished finish, stamped "14K michael hill 61555200103" - acid tested as 14 carat gold.

Finger size = K.

The ring contains;

One claw set Princess cut diamond (laser inscribed), clarity is "P1", colour is "I", medium cut quality.

Dimensions = 4.94mm (L) x 4.73mm (W) x 3.52mm (D-estimated)

Total Weight = 0.76ct (estimated - see NOTE below).

Thirty bead set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "H to I"(mixed), medium cut quality.

Dimensions = 1.60mm (average diameter) x 0.98mm (D-estimated)

Total Weight = 0.45ct (estimated - see NOTE below).

Total Item Weight = 4.84 grams, Total Gemstone Weight = 1.21ct, Total Metal Weight = 4.60 grams (estimated)

NOTE: Limited gemmological testing, inset. The Princess cut diamond, has a laser inscription to the girdle "Michael Hill 61555200103". Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
