### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, 18ct white gold, multistone ring, of hand-assembled construction.

Plain, narrow, flat, tapered band of 2.77mm width (at base) x 0.89mm depth, with open back settings.

Feature rectangle top plate, housing one row of three round natural sapphires, alternating with two single cut diamonds, claw set. The top plate is secured to the top of the plain and polished white gold band.

Polished finish.

Stamped '18ct WD 7110 0A60X100(engraved)' - acid tested as 18 carat gold.

Ring size: L.

The ring contains:

Three claw set round natural sapphires, colour is "blue".

Dimensions (average) = 2.40mm(Dia) x 1.46mm(D-estimated) x 2%(Bulge)

Total Weight = 0.18ct (estimated - see NOTE below)

Two claw set single cut diamonds, clarity is "Vs & Si" (mixed), colour is "G to H" (mixed).

Dimensions (average) = 1.80mm (diameter)

Total Weight = 0.05ct (estimated - see NOTE below)

Total Item Weight = 3.25 grams Total Gemstone Weight = 0.23ct Total Metal Weight = 3.20 grams (estimated)

NOTE: One of the sapphires has a large chip to the crown facets. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
