### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, 18ct yellow gold and 18ct white gold, gem set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, flat, tapered band of 2.13mm width (at base) x 0.87mm, with open back settings, and a curved underrail.

Feature central white gold illusion setting, housing one round brilliant cut diamond, illusion set. Surrounding is one row of ten single cut diamonds, varying slightly in size, claw set. The top plate is supported with an open wire base, and is secured between the upswept and square shoulders, of the plain and polished yellow gold band.

Polished finish.

Stamped '750' - acid tested as 18 carat gold.

Ring size: K 1/2.

The ring contains:

One claw set round brilliant cut diamond, clarity is "Si2", colour is "H".

Dimensions = 3.69mm(Dia) x 2.25mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.18ct (estimated - see NOTE below)

Ten claw set single cut diamonds, clarity is "Vs & Si" (mixed), colour is "H to I" (mixed).

Dimensions (average) = 1.75mm (diameter)

Total Weight = 0.22ct (estimated - see NOTE below)



Total Item Weight = 3.58 grams Total Gemstone Weight = 0.40ct Total Metal Weight = 3.50 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
