Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, multistone, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 1.82mm width (at base) x 1.14mm depth, with a curved underrail.

Feature central four claw setting, housing one oval shaped diamond, claw set. Surrounding is one row of fourteen round brilliant cut diamonds, claw set. The top plate is secured to the underrail, and in between the extended and square shoulders, of the plain and polished band. The underrail and edges of the shoulders houses a total of thirty-six round brilliant cut diamonds, claw set.

Polished finish.

Stamped '18K 750 unknown makers mark' - acid tested as 18 carat gold.

Ring size : O.

The ring contains:

One claw set oval shaped diamond, clarity is "Si2", colour is "I".

Dimensions = 6.05mm(L) x 4.43mm(W) x 2.70mm(D-estimated) x 3.5%(Girdle Thickness)

Total Weight = 0.47ct (estimated - see NOTE below)

Sixty claw set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "H to I" (mixed).

Dimensions = 1.10mm(Dia) x 0.67mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.70mm(Dia) x 1.04mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.50ct (estimated - see NOTE below)

Total Item Weight = 3.87 grams Total Gemstone Weight = 0.97ct Total Metal Weight = 3.68 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
