Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold, gem set, 'cluster' style ring, of cast construction.

Plain, narrow, low half round, tapered band of 1.59mm width (at base) x 1.18mm depth, with open back settings, and a decorative underrail.

Feature round top plate, with a central four claw setting, housing one round brilliant cut diamond, claw set. Surrounding is two rows of round brilliant cut diamonds. The top plate is secured to the upswept shoulders, of the plain and polished band. Each of the shoulders houses one row of seven round brilliant cut diamonds, claw set. There are a total of fifty-five round brilliant cut diamonds. Rhodium plating to the gallery, and diamond setting areas.

Polished finish.

Unstamped - acid tested as 18 carat gold.

Ring size: P.

The ring contains:

One claw set round brilliant cut diamond, clarity is "P1", colour is "I".

Dimensions = 4.10mm(L) x 4.06mm(W) x 2.48mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.24ct (estimated - see NOTE below)

Fifty Five claw set round brilliant cut diamonds, clarity is "P1 & P2" (mixed), colour is "H to I" (mixed).

Dimensions = 1.05mm(Dia) x 0.64mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.41mm(Dia) x 0.86mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.44ct (estimated - see NOTE below)

Total Item Weight = 5.16 grams Total Gemstone Weight = 0.68ct Total Metal Weight = 5.02 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
