Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct white gold, gem set, 'cluster' style ring, of cast construction.

Plain, narrow, low half round band of 1.15mm width (at base) x 1.00mm depth, with open back settings, and a curved underrail.

Feature central four claw setting, housing one oval natural sapphire, claw set. Surrounding is one floating row of sixteen round brilliant cut diamonds, claw set. The top plate is secured between the shoulders of the plain and polished band.



Polished finish.

Stamped '375 H' - acid tested as 9 carat gold.

Ring size: M.

The ring contains:

One claw set oval shaped natural sapphire, colour is "blue".

Dimensions = $5.01 \text{mm}(L) \times 3.99 \text{mm}(W) \times 2.85 \text{mm}(D\text{-estimated})$

Total Weight = 0.48ct (estimated - see NOTE below)

Sixteen claw set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "G to H" (mixed).

Dimensions (average) = 1.30mm(Dia) x 0.79mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.16ct (estimated - see NOTE below)

Total Item Weight = 1.38 grams Total Gemstone Weight = 0.64ct Total Metal Weight = 1.25 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
