Valuation for Traditional Retail Insurance Replacement

One, 18ct white gold, gem set, multistone ring, of hand-assembled construction.

Plain, narrow, low half round band of 2.84mm width (at base) x 1.53mm depth, with open back settings.

Feature central four claw setting, housing one Princess cut diamond, claw set. The setting is secured in between the shoulders of the plain and polished band. Each of the shoulders houses one row of four Princess cut diamonds, channel set.

Polished finish.

Stamped '750' - acid tested as 18 carat gold.

Ring size: M 1/2.

The ring contains:

One channel set Princess cut diamond, clarity is "Vs & Si" (mixed), colour is "G to H" (mixed).

Dimensions = 4.66mm(L) x 4.62mm(W) x 3.25mm(D-estimated) x 3%(Girdle Thickness)

Total Weight = 0.60ct (estimated - see NOTE below)

Eight channel set Princess cut diamonds, clarity is "Vs & Si" (mixed), colour is "G to H" (mixed).

Dimensions (average) = 1.50mm(L) x 1.5mm(W) x 1.06mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.16ct (estimated - see NOTE below)

Total Item Weight = 6.31 grams Total Gemstone Weight = 0.76ct Total Metal Weight = 6.16 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
