Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, hand-assembled raised, 18ct white gold & gemset, multistone ring. Plain, narrow, low half round, tapered band, measures 1.59mm width (at base) x 1.23mm depth, with curved underrail, open back settings, underneath. Feature, "cluster style" ring design. Comprising, a square cushion-shaped cluster setting to top. Housing one cushion modified brilliant cut, "laboratory grown synthetic diamond" (laser inscribed & certified), claw set. Drops to a surround, containing twenty round brilliant cut, "laboratory grown synthetic diamonds", claw set. A v-shaped undercarriage having two chenier rub-over settings, houses two round brilliant cut "laboratory grown synthetic diamonds", rub-over set. The extended shoulders, of the band, tapers up, each shoulder contains ten round brilliant cut, "laboratory grown synthetic diamonds", claw set, both sides. Polished finish, stamped "750 ANAI (partial)" - acid tested as 18 carat gold. Finger size = K.



The ring contains;

One claw set cushion cut (modified brilliant) 'laboratory grown synthetic' diamond, clarity is "Si1", colour is "I", good cut quality.

Dimensions = 7.11mm (L) x 7.04mm (W) x 4.77mm (D-estimated) x 15%(Girdle Thickness)

Total Weight = 2.03ct (known weight - see NOTE below).

Forty Two claw set round brilliant cut 'laboratory grown synthetic' diamonds, clarity is "Vs & Si"(mixed), colour is "G to H"(mixed), medium cut quality.

Dimensions = 1.41mm (average diameter) x 0.86mm (D-estimated) Total Weight = 0.63ct (estimated - see NOTE below).

Total Item Weight = 3.58 grams, Total Gemstone Weight = 2.66ct, Total Metal Weight = 3.05 grams (estimated)

NOTE: Limited gemmological testing, inset. The cushion cut modified brilliant "laboratory grown synthetic diamond", has been certified by, and is the opinion of, Messrs. International Gemological Institute, Certificate no. LG 10972602. Dated January 31, 2019. The cushion cut modified brilliant "laboratory grown synthetic diamond", has also been laser inscribed upon the girdle with IGI (logo) and LG 10972602. Due to setting constraints, the exact dimensions of the other round brilliant cut, "laboratory grown synthetic diamonds", cannot be ascertained. Therefore, weight of the other round brilliant cut, "laboratory grown synthetic diamonds", are very much estimated. For accurate testing, weights, colour, and clarity gradings, the other round brilliant cut, "laboratory grown synthetic" diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
