Valuation for Traditional Retail Insurance Replacement

Item 1

One, 10ct gold, gem set, multistone ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 2.22mm width (at base) x 0.73mm depth, with open back settings, and a curved underrail.

Feature 'vintage' style ring, with five multi-claw settings, spanning across the top of the band. Each housing one round brilliant cut diamond, slightly graduating in size, largest to the centre, claw set. The settings are secured to the top of the band. The shoulders are embellished with 'arrow' and a 'donut' shaped elements.

Polished finish.

Unstamped - acid tested and x-rayed.

Ring size: Q.

The ring contains:

Five claw set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "H to J" (mixed).

Dimensions = 3.15mm(Dia) x 1.92mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 3.30mm(Dia) x 2.01mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.62ct (estimated - see NOTE below)

Total Item Weight = 3.21 grams

Total Gemstone Weight = 0.62ct

Total Metal Weight = 3.09 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
