### Valuation for Traditional Retail Insurance Replacement

**Item 1**

One, 18ct yellow gold, gem set, 'three stone' style ring, of hand-assembled construction.

Plain, low half round band of 2.51mm width (at base) x 1.11mm depth, with a hollow top and shoulders, and open back settings.

Feature central bezel setting, housing one round brilliant cut diamond, bezel set. The setting is secured between the extended and square shoulders, in a 'wrap around' style, of the plain and polished band. Each of the shoulders is embellished with one bezel setting, housing one round brilliant cut diamond, bezel set.

Polished finish.

Stamped '750 18K' - acid tested as 18 carat gold.

Ring size: M.

The ring contains:

- Three bezel set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "G".
- Dimensions = 2.60mm(Dia) x 1.59mm(D-estimated) x 2%(Girdle Thickness) (smallest)
- Dimensions = 2.70mm(Dia) x 1.65mm(D-estimated) x 2%(Girdle Thickness) (largest)
- Total Weight = 0.20ct (estimated - see NOTE below)

Total Item Weight = 3.82 grams

Total Gemstone Weight = 0.20ct

Total Metal Weight = 3.78 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
