Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold, gem set, multistone ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 1.19mm width (at base) x 0.85mm depth, with open back settings, and a curved underrail.

Feature 'vintage' style ring with a central six claw setting, housing one round brilliant cut diamond, claw set. The setting is secured to the underrail, and in between the decorative shoulders of the plain and polished band. The shoulders are embellished with three round brilliant cut diamonds, bead set, and engraved detail.

Polished finish.

Stamped '750 illegible stamp' - acid tested as 18 carat gold.

Ring size: K 1/2.

The ring contains:

One claw set round brilliant cut diamond, clarity is "Si1", colour is "H".

Dimensions = 4.11mm(L) x 4.08mm(W) x 2.45mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.26ct (estimated - see NOTE below)

Six bead set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "G to H" (mixed).

Dimensions (average) = 1.40mm(Dia) x 0.85mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.07ct (estimated - see NOTE below)

Total Item Weight = 2.61 grams Total Gemstone Weight = 0.33ct Total Metal Weight = 2.54 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
