Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and 18ct white gold, gem set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 2.08mm width (at base) X 0.94mm depth, with open back settings, and a curved underrail.

Feature central white gold ten claw setting, housing one natural solid opal cabochon, claw set. Surrounding is one row of single cut diamonds, claw set. The top plate is secured to the underrail, and in between the extended and pointed shoulders, of the plain and polished yellow gold band.

Polished finish.

Stamped 'K18 S&Co' - Hallmarked in Birmingham, United Kingdom, 1984 - acid tested as 9 carat gold.

The ring contains:

One claw set oval natural white opal cabochon, with "green, blue, and violet" play of colours.

Dimensions = 7.70mm(L) x 6.30mm(W) x 2.19mm(D-estimated)

Total Weight = 0.62ct (estimated - see NOTE below)

Ten claw set single cut diamonds, clarity is "Vs & Si" (mixed), colour is "G to I" (mixed).

Dimensions (average) = 1.60mm (diameter)

Total Weight = 0.17ct (estimated - see NOTE below)

Total Item Weight = 3.05 grams Total Gemstone Weight = 0.79ct Total Metal Weight = 2.89 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
