Valuation for Traditional Retail Insurance Replacement

Item 1

One pair of, 18ct rose gold, gem set, 'cluster' style stud earrings, of hand-assembled construction.

Feature round top plate, housing seven round brilliant cut diamonds, largest to the centre, and invisibly and claw set. The earrings are finished with threaded posts and butterfly attachments.

Earring dimensions = 6.30mm (ave. length) x 6.16mm (ave. width) x 2.73mm (ave. depth).

Polished finish.

Stamped '18K 750 A6HZF3 PD 0.44 unknown makers mark' - acid tested as 18 carat gold.

The earrings contain:

Two invisibly set round brilliant cut diamonds, clarity is "Vs", colour is "G".

Dimensions (average) = 2.30mm(Dia) x 1.40mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.09ct (estimated - see NOTE below)

Twelve claw set round brilliant cut diamonds, clarity is "Vs", colour is "G".

Dimensions (average) = 1.90mm(Dia) x 1.16mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.35ct (estimated - see NOTE below)

Total Item Weight = 1.86 grams Total Gemstone Weight = 0.44ct Total Metal Weight = 1.77 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
