Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold, gem set, 'three stone' style ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 2.98mm width (at base) x 1.47mm depth.

Feature central four claw setting, housing one round brilliant cut diamond, claw set. Either side of the central setting, is a smaller four claw setting, each housing one round brilliant cut diamond, claw set. The settings are secured between the extended and pointed 'ramp' style shoulders, of the plain and polished band.



Polished finish.

Stamped 'DL 750' - acid tested as 18 carat gold.

Ring size: P 1/2.

The ring contains:

One claw set round brilliant cut diamond, clarity is "Si1", colour is "H".

Dimensions = 4.44mm(L) x 4.42mm(W) x 2.95mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.36ct (estimated - see NOTE below)

Two claw set round brilliant cut diamonds, clarity is "Si", colour is "G to H" (mixed).

Dimensions (average) = 3.61mm(Dia) x 2.20mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.36ct (estimated - see NOTE below)

Total Item Weight = 4.41 grams Total Gemstone Weight = 0.72ct Total Metal Weight = 4.27 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
