### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, 18ct yellow gold and 18ct white gold, gem set, multistone ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 2.02mm width (at base) x 0.99mm depth, with open back settings, and a curved underrail.

Feature 'wrap around' style ring, with one termination housing one cultured pearl, end set. The termination splits into seven wires, each with a white gold four claw setting, housing one round brilliant cut diamond, claw set. The other termination extends out from the plain and polished yellow gold band.

Polished finish.

Stamped '1HK750' - acid tested as 18 carat gold.

Ring size: O 1/2.

The ring contains:

One end-drilled round cultured pearl, colour is "white".

Dimensions = 6.00mm(Dia)

Seven claw set round brilliant cut diamonds, clarity is "Vs & Si & P1 & P2" (mixed), colour is "tinted brown".

Dimensions (average) = 2.30mm(Dia) x 1.40mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.32ct (estimated - see NOTE below)

Total Item Weight = 4.00 grams

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
