Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand-assembled raised, 14ct yellow gold & sterling silver, diamond set, multistone ring. Plain, narrow, low half round, tapered band, measures 2.36mm width (at base) x 1.18mm depth, with curved underrail.

Feature, "cluster style" ring design, with shoulder stones. Comprising, a silver illusion cluster to top, houses One round brilliant cut diamond, to centre, illusion claw set. Drops to a double surround, contains thirty single cut diamonds, illusion bead set. The extended shoulders, of the yellow gold band tapers up to the extension silver bead setting ontop, each side, contains three single cut diamonds.



Polished finish, unstamped - acid tested & x-rayed. Finger size = O.

The ring contains;

One illusion claw set round brilliant cut diamond, clarity is "Si", colour is "H", medium cut quality.

Dimensions = 3.40mm (average diameter) x 2.07mm (D-estimated)

Total Weight = 0.15ct (estimated - see NOTE below).

Thirty Six illusion & bead set single cut diamonds, clarity is "Vs & Si"(mixed), colour is "H to I"(mixed), medium cut quality.

Dimensions = 1.20mm (average diameter) (smallest)

Dimensions = 1.40mm (average diameter) (largest)

Total Weight = 0.45ct (estimated - see NOTE below).

Total Item Weight = 4.30 grams, Total Gemstone Weight = 0.60ct, Total Metal Weight = 4.18 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
