## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, lady's, hand finished, raised 18ct white gold & diamond set, solitaire ring.

Plain, narrow, low half round, tapered band, measures, a raised four claw setting to top, houses one marquise cut diamond, claw set, with curved underrail.

Feature, "solitaire style" ring design. Comprising, a raised four claw setting, houses one marquise cut diamond, claw set. The extended shoulders, of the band tapers up to the top, from both sides.



Polished finish, stamped "18ct" - acid tested as 18 carat gold.

Finger size = N1/2.

The ring contains;

One claw set marquise cut diamond, clarity is "Si", colour is "G", medium cut quality. Dimensions = 8.59mm (L) x 5.00mm (W) x 3.05mm (D-estimated) Total Weight = 0.75ct (estimated - see NOTE below).

Total Item Weight = 3.41 grams, Total Gemstone Weight = 0.75ct, Total Metal Weight = 3.26 grams (estimated)

NOTE: Limited gemmological testing inset. Due to setting constraints, the exact dimensions of the diamond cannot be ascertained. Therefore, weight of the diamond are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamond, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
