### Valuation For Traditional Retail Insurance Replacement

#### Item 1

One lady's hand-assembled 18ct yellow gold & 18ct white gold, diamond set ring.

Flat, tapered from 1.85mm in width at base x 1.09mm in depth shank with curved underrail. Pointed offset shoulders, each channel set with 5 round brilliant cut diamonds. Central white gold 'diamond' shape setting housing a Princess cut diamond.

Polished finish, stamped WB 750 " and acid tested. Finger size = J

The ring contains:

One claw set Princess cut diamond, clarity "VS", colour "I", medium to good cut quality.  
Dimensions = 3.65mm(L) x 3.58mm(W) x 2.54mm(D-estimated)  
Total Weight = 0.27ct (estimated) see NOTE below

Ten channel set round brilliant cut diamonds, clarity "VS & Si", colour "G to H", medium to good cut quality.  
Dimensions = 1.59mm(Diameter) x 0.97mm(D-estimated) (smallest)  
Dimensions = 1.93mm(Diameter) x 1.18mm(D-estimated) (largest)  
Total Weight = 0.23ct (estimated) see NOTE below

Total Item Weight = 3.10 grams, Total Gemstone Weight = 0.50ct, Total Metal Weight = 3.00 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weights of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
