Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand finished, raised 18ct white gold & diamond set, multistone ring, of cast construction.

Plain, wide, low half round, tapered band, measures 3.52mm width (at base) x 0.73mm depth, with curved underrail, open back setting, underneath. Feature, "square shaped, cluster design, with undercarriage & shoulder stones. Comprising, a raised four claw setting to centre, drops to a surround. The underrail & extended shoulders, taper up, split into three rows are all diamond set.



Polished finish, stamped "750" - acid tested as 18 carat gold. Finger size = Q.

The ring contains;

One claw set Princess cut diamond, clarity is "Si", colour is "H", medium cut quality.
Dimensions = 4.65mm (L) x 4.61mm (W) x 3.15mm (D-estimated) x 3%(Girdle Thickness)
Total Weight = 0.61ct (estimated - see NOTE below).

Eighty Five claw set round brilliant cut diamonds, clarity is "Si", colour is "H", medium cut quality.
Dimensions = 0.85mm (average diameter) x 0.52mm (D-estimated) (smallest)
Dimensions = 1.46mm (average diameter) x 0.89mm (D-estimated) (largest)
Total Weight = 0.70ct (estimated - see NOTE below).

Total Item Weight = 3.99 grams, Total Gemstone Weight = 1.31ct, Total Metal Weight = 3.73 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
