## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, lady's, raised 18ct yellow gold & gemstone set (mixed), cluster style dress ring, of cast construction. Plain, narrow, low half round, tapered bands, measures 2.16mm width (at base) x 0.82mm depth, with curved underrail.

Feature, "cluster style" ring design. Comprising, a raised four claw setting to centre, houses one oval shaped, faceted, natural sapphire, claw set. Drops to a surround, containing ten round brilliant cut diamonds, claw set. The extended shoulders, of the band, taper up, to pointed end terminations, to one side of the central setting.



Polished finish, stamped "18CT" - acid tested as 18 carat gold. Finger size = O.

The ring contains;

One claw set oval-shaped, faceted, natural sapphire, colour is "medium dark - blue".  
Dimensions = 6.33mm (L) x 5.21mm (W) x 4.05mm (D-estimated) x 5%(Bulge)  
Total Weight = 1.18ct (estimated - see NOTE below).

Ten claw set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "H to I"(mixed), medium cut quality.  
Dimensions = 1.44mm (average diameter) x 0.88mm (D-estimated)  
Total Weight = 0.11ct (estimated - see NOTE below).

Total Item Weight = 4.90 grams, Total Gemstone Weight = 1.29ct, Total Metal Weight = 4.64 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
