## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, lady's, hand finished, raised 18ct white gold & diamond set, solitaire ring. Plain, narrow, low half round, tapered band, measures, 2.40mm width (at base) x 1.24mm depth. With curved underrail.

Feature, "solitaire style" ring. Comprising, a raised four claw coronet, housing one round brilliant cut diamond (glass filled), claw set. The extended shoulders, of the band, tapers up to the top, with pointed end terminations, to both sides.

Polished finish, stamped "750" - acid tested as 18 carat gold.

Finger size = N.

The ring contains;

One claw set round brilliant cut diamond, medium cut quality.  
Dimensions = 5.08mm (Diameter) x 3.10mm (D-estimated)  
Total Weight = 0.50ct (estimated - see NOTE below).

Total Item Weight = 3.10 grams, Total Gemstone Weight = 0.50ct, Total Metal Weight = 3.00 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamond cannot be ascertained. Therefore, the weight of the diamond is very much an estimation. The diamond has been enhanced by means of filling with a glass type substance. This treatment is not stable and can be damaged by heat or ultrasonic frequencies. Due to this filling, colour and clarity gradings have not been assigned. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques with a fractured filled diamond of similar appearance being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
