One lady's, hand finished, raised 18ct white gold & diamond set, multistone ring. Plain, narrow, low half round, tapered band, measures, 2.20mm width (at base) x 1.23mm depth, with curved underrail.

Feature, "solitaire style" with shoulder stones. Comprising, a raised four claw setting to top, houses one Princess cut diamond, claw set. The extended shoulders, of the band, tapers up to the top. Each shoulder contains five Princess cut diamonds, graduate sizes, channel set, both sides.



Polished finish, stamped "18ct, CG" - acid tested as 18 carat gold. Finger size = K1/2.
