Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct rose gold, gem set, 'dress' style ring, of cast construction.

Plain, narrow, low half round band of 2.66mm width (at base 0 x 1.27mm depth, with an open back setting, and a curved underrail.

Feature central decorative 'scroll' style eight claw setting, housing one emerald cut natural citrine, claw set. The setting is secured to the top of the split style shoulders, of the plain and polished band.

Polished finish.

Stamped 'illegible stamp' - acid tested and x-rayed as approximately 18 carat gold.

Ring size: P.

The ring contains:

One claw set emerald cut natural citrine, colour is "yellow".

Dimensions = 11.76mm(L) x 8.54mm(W) x 8.06mm(D-estimated)

Total Weight = 5.36ct (estimated - see NOTE below)

Total Item Weight = 8.64 grams

Total Gemstone Weight = 5.36ct

Total Metal Weight = 7.57 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
