## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, 18ct yellow gold, gem set, 'cluster' style dress ring, of cast construction.

Plain, narrow, low half round, tapered band of 2.63mm width (at base) x 0.76mm depth, with open back settings, and a curved underrail.

Feature central round cultured pearl, end set. Surrounding is one row of sixteen round brilliant cut diamonds, varying in size, and bead set. The top plate is secured to the underrail, and in between the extended and pointed shoulders of the plain and polished band.



Polished finish.

Stamped '750' acid tested as 18 carat gold.

Ring size: Q.

The ring contains:

One end-drilled round cultured pearl, colour is "cream".

Dimensions = 6.85mm(L) x 6.75mm(W)

Sixteen bead set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "H to J" (mixed).

Dimensions = 1.44mm(Dia) x 0.88mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.53mm(Dia) x 0.93mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.24ct (estimated - see NOTE below)

Total Item Weight = 3.75 grams Total Gemstone Weight = 0.24ct Total Metal Weight = 3.70 grams (estimated)

NOTE: There is significant wear to the nacre of the central pearl, and it has been priced accordingly. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
