Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, 'cluster' style ring, of hand assembled construction.

Plain, narrow, flat, tapered band of 2.64mm width (at base) x 0.89mm depth, with open back settings.

Feature central six claw setting, housing one round synthetic emerald, claw set. Surrounding is three, four claw settings, each housing one round brilliant cut diamond, claw set. The settings are secured between the extended and 'flared' style shoulders, embellished with a beaten texture.

Polished finish.

Stamped '18CT' - acid tested as 18 carat gold.

Ring size: P.

The ring contains:

One claw set round synthetic emerald, colour is "green".

Dimensions = 4.68mm(L) x 4.66mm(W) x 2.84mm(D-estimated) x 1%(Bulge)

Total Weight = 0.30ct (estimated - see NOTE below)

Three claw set round brilliant cut diamonds, clarity is "Si", colour is "G to H" (mixed).

Dimensions (average) = 2.00mm(Dia) x 1.22mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.09ct (estimated - see NOTE below)

Total Item Weight = 5.58 grams Total Gemstone Weight = 0.39ct Total Metal Weight = 5.50 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
