One, 18ct yellow gold and 18ct white gold, diamond set, multistone ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 1.76mm width (at base) x 0.84mm depth, with open back settings, and a curved underrail.

Feature central white gold six claw setting, housing one round brilliant cut diamond, claw set. The setting is secured to the underrail and in between the extended and pointed shoulders, in a 'wrap around' style, of the plain and yellow gold polished band. One of the shoulders houses one row of four round brilliant cut diamonds, slightly graduating in size, and channel set.

Polished finish.
